

Nation-o-cide (Part 2)

The targeting of specific countries

Not all countries are viewed favorably by those orchestrating this “pandemic” and its associated “vaccine”. In particular, those countries that opted for a consent-based approach to the vaccine appear to be on the receiving end of the most lethal vaccine batches !

Definition: the lethality of a lot = % of reports for that lot having a fatal outcome

Japan appears prominently as a recipient of the most lethal lots. Notice that Japan is receiving ALL nine of the most lethal Pfizer lots !!

Was the assassination of the Japanese President also a coincidence?

What About Severity?

Definition : The severity of a lot = the % of reports having a severe outcome such as death, disability or life threatening illness.

Belgium has been the recipient of the most severe batches, since Belgium was in receipt of ALL 7 of the batches generating the greatest amount of disability.

Astonishingly, for Belgium up to 92% of the reports for some lots resulted in serious disability !
For Batch number 000057A (a Moderna batch) - out of 136 reports, 125 resulted in disability !

For comparison, the maximum severity of any batch in the UK is 23 %
